In pursuance of the authority received from reference-1 and 2, verifying the provisions of order 1 (a) to 12 of Education Department Resolution No. : UMSH-1295/EMR/63/C-1 dated 31-1-97 and in view of the provisions of Resolution No. UMSH-1295/EMR-61-G-1 dated 1-10-97, the first increment of Standard-9 is sanctioned subject to the following conditions subject to the condition of not taking permanent grant from June-2006.

- (1) If this sanction is given on condition of non-receipt of grant on a permanent basis, the Institution cannot claim for grant in future.
- (2) The students shall be allowed as per the ratio decided by the Government.
- (3) The curriculum as decided by the Government shall be conducted in the school.
- (4) The fee shall be as decided by the Government from time to time.
- (5) In case of class closure or closure of a non-grant school, the teachers of such school will not get the benefit of the protection provided by the government to spare teachers and the full responsibility of such spare teachers will be with the institution.
- (6) All financial responsibility including salary and pension of the employees appointed to the academic posts created under the above successive/ additional class approval shall be the responsibility of the institution.
- (7) In the event of closure of the entire school or its classes, if circumstances arise to lay off any employee, the responsibilities of the institution, the governing body, and the responsibility of paying compensation as per the provisions thereof, as applicable from time to time, shall also be the responsibility of the governing body.

It is to inform on the aforesaid subject and reference that your proposal to commence the first class of English medium Standard-10 without grant from June-2007 in the above mentioned school has been received by the Board through the office of the District Education Officer vide reference-2 letter. In accordance with the provisions of the Gujarat Secondary and Higher Secondary Education Act-1992 (Gujarat Act No.: 18 of 1973) and the Gujarat Secondary Education Regulations-1974 made there-under and related Government Resolutions / Board circulars from time to time, your school is permitted to start the first consecutive class of Standard-10 from June-2007 in a non-grant secondary school run by your school board with the following conditions.

- (1) The school building should have adequate provision of classrooms with adequate area and adequate ventilation as well as sanitary facilities as per rules.
- (2) Due to this increase in classes, as per the requirement of the subjects, the necessary qualified teachers have to be appointed immediately. In this connection, you have to get the guidance of your district education officer and implement it accordingly. After recruiting the teachers, the teacher registration form will have to be filled and sent to the office of the District Education Officer within the stipulated period.

- (3) After starting the class of Standard-10, a principal with the necessary qualifications has to be appointed as per the rules and before starting the class of Standard-10, the school will have to get the staff profile approved by the office of the District Education Officer.
- (4) The adequate provision of laboratory, science equipments, other educational equipments and furniture should be made available in accordance with the Standard-10 curriculum.
- (5) The school library should be enriched by purchasing necessary and useful supplementary reading books for teachers and students as per the prescribed curriculum.
- (6) The due care should be taken that there will no unhealthy competition for numbers with local or neighboring secondary schools.
- (7) As per rules, the amount should be kept in a joint account and the cheque will be used to pay the salary of the teachers.
- (8) There should be arrangements for land, hostels, workshops etc. in the Uttar Buniyadi School as per industry norms.
- (9) The students of own school have to be included in this class first. There will be no discrimination for admission of students.
- (10) The conditions stated in the Government's letter No.: BMSH/1093/1322/6 dated 17/7/93 and Education Department's letter No. BMSH/1293/1322/6 dated 21/7/93 shall be complied with.
- (11) This permission is given subject to have got all permissions regarding the building construction and play ground of the school. Hence, the District Education Officer will have to make assured in this regard.
- (12) The School Board will have to verify these kinds of evidences/certificates going personally to the concerned university/institution received from the University outside of the Gujarat State/certificates from the institution and the school board will be liable for this.
- (13) The institution/Governing body will have to manage of all kinds of safety with regard to the fire safety.

## CONDITIONS REGARDING REGISTRATION

- (1) The Board should be satisfied that the governing body of the school is competent and reliable and that it is administered by a properly constituted Board of Management and that it is financially viable.
- (2) The officers of the Board or the person authorized by the Board and the Inspector/Officers of the Education Department shall be allowed to inspect the school.
- (3) The school should have a building with necessary facilities, furniture, laboratory, equipment, stationery and other materials as per the standards specified in the regulations and circulars made by the Board and should have academic and non-academic staff appointed as per the rules as per the qualifications specified in the regulations. In addition, the school should provide adequate health facilities for the students.
  - (a) If there is a Uttar Bhniyadi School, education of the industry indicated in the structure has to be imparted and provision of land, water, workshop, workshop etc. as per the rules has to be made according to the industry.
  - (b) The North Basic School shall make hostel arrangements.
- (4) The Board should be satisfied that the education provided in the school is satisfactory in all respects.
- (5) The school shall use only the syllabus approved by the Government and the text books approved from time to time.
- (6) The students in different standards may be admitted only as per the conditions prescribed by the Board.
- (7) The promotion of students from one grade to a higher grade in a school shall be according to the norms fixed by the Board for Examination of Students.
- (8) The rates of education fees and pay scales of academic and non-academic employees should be approved by the Government.
- (9) The school shall prepare and maintain such registers and records as may be prescribed by the Board with necessary particulars within the time limit.
- (10) The records, the statistics sheets and the certificates furnished by the school principals or administrators should be reliable.
- (11) The Board shall ensure that the school staff and students comply satisfactorily with the disciplinary rules prescribed by the Board from time to time.
- (12) The governing body should ensure that no invalid school or class, tuition class is running in the school building.
- (13) The Board shall not prepare and send the same candidate who has passed one of the examinations conducted by the Board again (second time) for the same examination.
